AFDC STATEMENT OF BENEFITS 2006	A Statement from the Department of Family and Children Services which shows your and your family's total benefits for Calendar Year 2006.
ALIEN REGISTRATION	A copy of applicable registration (I-151, or I-551, I-151C, I-797 with approved immigrant visa, I-64 or I-668). <b><u>If you are a US Citizen, provide a copy of your birth certificate. If you are a Naturalized Citizen, provide copy of citizenship papers.</u></b>
BIRTH CERTIFICATE OF DEPENDENT CHILD	A copy of your dependent child's birth certificate.
DRUG REHABILITATION DOCUMENTATION	A signed and dated written statement indicating that you have completed an acceptable drug rehabilitation program since your last conviction.
DRUG WORKSHEET	The GCSU Financial Aid Office provides this federal form.
GSFAPPS (HOPE Scholarship & Grant Application)	Students who are interested in receiving the <b>HOPE Scholarship only</b> , may apply using this form in place of the Free Application for Federal Student Aid (FAFSA). This application may be complete on-line at <a href="http://www.gacollege4ll.org">www.gacollege4ll.org</a> .
INSTITUTIONAL STUDENT INFORMATION RECORD (ISIR)	By completing the Free Application for Federal Student Aid (FAFSA), an ISIR is produced electronically for all schools listed by the student. If a school cannot receive these application results by this electronic process, the student must provide the original Student Aid Report (SAR) issued to them by the Federal Processing Center.

PARENT(S) ENTIRE FEDERAL TAX RETURN 2006	<b><u>An Exact signed copy, including all W-2's, schedules and attachments as submitted to the IRS of the 2006 Federal Income Tax Return.</u></b> At the top of the copy please indicate the student's name and social security number. NOTE: Declaration for electronic filing is not considered a tax return
SELECTIVE SERVICE	A copy of Selective Service registration form.
SOCIAL SECURITY BENEFITS 2006	Security Administration statement showing you and your family's total benefits for 2006.
SOCIAL SECURITY CARD	A copy of the student's Social Security Card.
STUDENT/SPOUSE'S ENTIRE FEDERAL TAX RETURN 2006	<b><u>An exact signed copy, including all W-2's, schedules and attachments as submitted to the IRS for the 2006 Federal Income Tax Return.</u></b> NOTE: Declaration for electronic filing is not considered a tax return. If you filed a TeleFile, make sure to sign at bottom of page.
TITLE IV INCOME EXCLUSIONS	A written explanation of the amount in: "Title IV Income Exclusions" on the FAFSA on question number 42 for the student or 86 for the parents, worksheet C. If any portion of the reported amount is Child Support paid by you or your parents, indicate the total amount paid in 2006. This statement must include your/your parent's signature and your social security number.
UNTAXED INCOME	A written explanation of Untaxed Income you reported on the FAFSA on question number 40, worksheet A or 41, worksheet B for the students. For the parents refer to question 84, worksheet A or question 85, worksheet B.
