AFDC STATEMENT OF BENEFITS 2008	A statement from the Department of Family and Children Services which shows you and your family's total benefits for Calendar Year 2008.
ALIEN REGISTRATION	A copy of applicable registration (I-151, I-551, I-151C, I 797 with approved immigrants visa, I-64 or I-668). If you are a US citizen, provide a copy of your birth certificate. If you are a Naturalized Citizen, provide copy of citizenship papers.
BANKRUPTCY STATEMENT	A written signed statement from student stating that any future loans you may be eligible for cannot be relieved by bankruptcy.
BIRTH CERTIFICATE OF DEPENDENT CHILD	A copy of your dependent child's birth certificate.

DRUG REHABILITATION DOCUMENTATION	A signed and dated written statement indicating that you have completed an acceptable drug rehabilitation program since your last conviction.

If you are unable to provide these documents, please contact the Financial Aid Office for further instructions.

PARENT(S) ENTIRE FEDERAL TAX RETURN 2008	An exact signed copy, including all W-2's, schedules and attachments as submitted to the IRS of the 2008 Federal Income Tax Return. At the top of the copy please indicate the student's name(s) and social security number. NOTE: Declaration of electronic filing is not considered a tax return.
SELECTIVE SERVICE	A copy of Selective Service registration form.
SOCIAL SECURITY CARD	A copy of the student's Social Security Card.
STUDENT/ SPOUSE'S ENTIRE FEDERAL TAX RETURN 2008	An exact signed copy, including all W-2's, schedules and attachments as submitted to the IRS for the 2008 Federal Income Tax Return. NOTE: Declaration for electronic filing is not considered a tax return. If you filed a TeleFile, make sure to sign at bottom of page.
VETERANS ADMINISTRATION BENEFITS	If you are receiving or expect to receive Veteran's Benefits, provide verification of amount and duration of time you are to receive such benefits.
