<b>AFDC STATEMENT OF BENEFITS 2008</b>	A statement from the Department of Family and Children Services which shows you and your family's total benefits for Calendar Year 2008.
<b>ALIEN REGISTRATION</b>	A copy of applicable registration (I-151, I-551, I-151C, I 797 with approved immigrants visa, I-64 or I-668). <b>If you are a US citizen, provide a copy of your birth certificate. If you are a Naturalized Citizen, provide copy of citizenship papers.</b>
<b>BANKRUPTCY STATEMENT</b>	A written signed statement from student stating that any future loans you may be eligible for cannot be relieved by bankruptcy.
<b>BIRTH CERTIFICATE OF DEPENDENT CHILD</b>	A copy of your dependent child's birth certificate.
<b>CONFIRMATION OF VA EDUCATION BENEFITS 2009-2010</b>	Form can be accessed by clicking on the name of the document to your left. Please complete and submit to the Financial Aid Office
<b>DEPENDENT VERIFICATION WORKSHEET</b>	Forms can be accessed by clicking on the Name of the Document to your left. Please complete and submit to Financial Aid Office
<b>DRUG REHABILITATION DOCUMENTATION</b>	A signed and dated written statement indicating that you have completed an acceptable drug rehabilitation program since your last conviction.

<b>FATHER'S BIRTH CERTIFICATE</b>	Copy of Father's Birth Certificate
<b>FATHER'S SOCIAL SECURITY CARD</b>	Copy of Father's Social Security Card
<b>GEORGIA RESIDENCY DOCUMENTATION</b>	In order to resolve your Georgia residency begin date for the HOPE Scholarship as reported on GSFApps, please provide Georgia Tax Returns for you and/or your parents for two years prior to your first enrollment at GCSU. <b>PARENT(S) ENTIRE FEDERAL TAX RETURN 2008</b>	An exact signed copy, including all W-2's, schedules and attachments as submitted to the IRS of the 2008 Federal Income Tax Return. At the top of the copy please indicate the student's name(s) and social security number. NOTE: Declaration of electronic filing is not considered a tax return.
<b>SELECTIVE SERVICE</b>	A copy of Selective Service registration form.
<b>SOCIAL SECURITY CARD</b>	A copy of the student's Social Security Card.
<b>STUDENT/ SPOUSE'S ENTIRE FEDERAL TAX RETURN 2008</b>	An exact signed copy, including all W-2's, schedules and attachments as submitted to the IRS for the 2008 Federal Income Tax Return. NOTE: Declaration for electronic filing is not considered a tax return. If you filed a TeleFile, make sure to sign at bottom of page.
<b>VETERANS ADMINISTRATION BENEFITS</b>	If you are receiving or expect to receive Veteran's Benefits, provide verification of amount and duration of time you are to receive such benefits.
