

Fall & Spring Schedule Planning Matrix

All **Fall and Spring courses**, except those noted below, should be scheduled at the following times. The common meeting time for Fall and Spring semesters is Fridays from 2-5 p.m. No classes should be scheduled during this time.

Class times may be extended for laboratory, clinical, and studio courses that require additional minutes of instruction, including GC2Y courses.

Since graduate students and students accepted to cohort programs enroll only in courses unique to their program, graduate courses and cohort programs may use alternate times, as long as the department coordinates courses within that program to maximize room usage. Approved cohort programs are Early Childhood Education, Middle Grades Education, Special Education, and Nursing.

Any other request to offer courses at alternate times requires the approval of the college dean and provost.

Summer Schedule Planning Matrix

All **Summer** courses, except those noted below, should be scheduled at the following times. There is no common meeting time during the summer semester.

Class times may be extended for laboratory, clinical, and studio courses that require additional minutes of instruction, including GC2Y courses.

Since graduate students and students accepted to cohort programs enroll only in courses unique to that program, graduate courses and cohort courses may use alternate times, as long as the department coordinates courses within that program to maximize room usage.

Any other request to offer courses at alternate times requires the approval of the college dean and provost.

Courses are not scheduled on Fridays, <u>unless</u> a course day is lost in the same week for a holiday. For example, classes that on Mondays during the May, May-June, or Full-Summer sessions will meet on the Friday after Memorial Day to make up the Monday class period.

Time for a ten minute break, to be used at the discretion of the instructor, is automatically included in the time allotment for each class. Classes marked with an asterisk have been allotted twenty minute breaks.
