## 4. Old/Continuing Business:

- Changes in Operating Procedures
  - Amendment Addition: If representatives are not present at the UCC meeting for the purposes of discussion and clarification of action items, action on the proposal may be postponed until a later meeting time.
  - Approved Unanimously
- Changes in Bylaws
  - Following the procedures set for changing the bylaws for the committee, the vote to approve amendments in the Bylaws will take place in the October meeting.
  - Proposed Amendments:
    - Section 1a: Proxy votes for the committee's voting membership are not allowed.
    - Section 1b: Vacancies (i.e. professional leave, sick leave, etc.) or resignations of elected committee members that occur during a term of service shall be filled for the remainder of that term following the process used in the original election of the committee member. The election to fill the vacancy should follow the guidelines stated in Section 1a. To initiate this process the representative from the academic unit (CoAS, CoBT CoHS, CoE, or Library), University Senate, or area of appointment should notify the Chair of the UCC in writing of the vacancy or resignation and the results of the election process. (Electronic forms of communication are acceptable.) Vacancies (i.e. professional leave, sick leave, etc.) or resignations of members who are appointed based upon position shall be filled following the original appointment process.
    - Section 2b: UCC meetings dates will be determined by the University Senate as a component of the Governance Calendar. The Governance Calendar for the upcoming year is set near the end of each academic year. The Chair of the UCC may make the decision to cancel a regularly scheduled meeting of the committee if no action items have come before the UCC for consideration. However, the UCC shall meet a minimum of one time each academic term or at the discretion of the committee chair. Additional meetings may be called at the discretion of the GCSU administration or at the request of two-thirds of the voting members.
