4. Demonstrate research-based and/or evidence-based instructional strategies relevant to the subject(s) taught.

5. Plan instruction with evidence-based strategies to meet the needs of all students.

6. Use student learning data to inform instructional goals and daily lessons.

7. Align instructional goals with state and local district performance standards.

8. Use a variety of research-based and/or evidence-based instructional strategies to facilitate students' acquisition of knowledge and skills.

9. Engage students in active learning activities relevant to the content.

10. Engage students in higher-order thinking activities.

11. Differentiate the instructional content to challenge and support each student's learning.

12. Maintain high expectations of students while differentiating instruction.

13. Use a variety of research-based and/or evidence-based instructional strategies to accommodate individual learning needs/goals.

14. Align student assessment with the established curriculum and learning goals.

15. Identify a variety of assessment strategies and instruments according to student population.

16. Use formal and informal methods of assessing student learning at multiple points (diagnostic, formative, and summative).

17. Systematically analyze assessment data to determine individual student needs and progress.

18. Use data to inform instructional content and delivery methods.

19. Use assessment results to provide constructive and frequent feedback to various stakeholders (including students and families) on progress toward learning goals.

20. Provide a safe environment that is conducive to learning for all.

21. Provide a positive environment that encourages respect for all.

22. Establish clear expectations, rules, routines, and procedures to promote a safe and orderly learning environment.

23. Create a student-centered environment that encourages students to explore new ideas as self-directed learners.

24. Create an academic environment that promotes critical and creative thinking.

25. Create a rigorous environment that encourages students to take appropriately challenging academic risks.

26. Follow professional ethics, policies, and legal codes of conduct.

27. Participate in professional learning activities, and incorporate learning into classroom activities to meet the needs of their students.

28. Engage in activities outside the classroom intended for school and student enhancement.

29. Work collaboratively with internal and external stakeholders, such as students, school and district personnel, families, and community representatives.

30. Communicate instructional goals and expectations with students and families.
