How do I find...

... the Faculty Handbook?

The Faculty Handbook is located on the catalog section of Academic Affairs. Visit the **Faculty Handbook website**. Some departments have specific manuals for faculty, so, check with your department administrative assistant or chair.

... maps of the campus?

View maps of the campus or use the Georgia College mobile app on your mobile device (download from yourmobile device app store.)

... the schedule of courses and classrooms?

The course schedule for all classes is on the **Office of the Registrar's** website.

To locate your class schedule, access PAWS from MyGCSU.

Select:

- Faculty Services tab
- Faculty Detail Schedule

... names and photos of students registered for my class?

Access PAWS, our Banner database with real-time student and class information, from MyGCSU (MyGCSU provides a single sign-on for many Georgia College online resources).

PAWS is the official faculty access point for studentinformation. Select:

- Term semester and year
- The CRN (course reference number) for your course
- GCSU Quick Course Roster by CRN
- View Class Roster with Photos

... email addresses for my students?

To find the email address for an individual student: Access PAWS from MyGCSU.

Select:

- Faculty Services tab
- · Student Email by CRN or
- Student Email by Student Name

To email one or more students in a class:

Access PAWS from MyGCSU.

Select

- Faculty Services tab
- CRN Selection > Select a Term

- Enrolled Students by CRN
- Summary Class List
 - O To email an individual student, click on the envelopeto the right of the student's name
 - O To email all students in the class, click the envelopeicon next to Email class below the class list

If using the GeorgiaVIEW learning management system: Access GeorgiaVIEW from MyGCSU.

Place a check by the student(s) you want to email and the E-mail hyperlink

Or

Click the check box to the left of the Email hyperlink only selects all of the students. Users still have to click the e-maillink icon.

... the academic calendar online?

The academic calendar is online through the Office of the Registrar. Select the semester and year (the academic calendar for undergraduate courses and graduate courses is the same).

... previous syllabi for the course I'm now teaching?

Check with an administrative assistant or the administrative officer in your department, college, or school about facultywho have taught the course in the past and the availability of previous syllabi.

... the final exam schedule for this semester?

The **final exam schedule** for the semester is located on the Office of the Registrar website.

... information about previous instructors for my course?

To locate information about previous instructors for your course, access PAWS from MyGCSU.

Select:

- Semester Course Schedules (formerly C.A.T.S)from the Main Menu
- Choose the term and subject.

The link for the Class Schedule is also located on the Campus Resources tab in MyGCSU.

You can also check with the department administrative assistant about previous instructors.

... the undergraduate and graduate catalogs for the university?

All University catalogs are available online University Catalogs website

... information about student rating of instruction?

The **Center for Teaching & Learning** provides informationabout the Student Rating of Instruction Survey (SRIS), which is the end-of-class survey.

... information about grade distribution?

You can view grade distribution in PAWS

Select: GCSU Reports > Grade Distribution > Term > Instructor Name

... advice on course or syllabus design, such as - how much work to assign my students?

For advice on teaching decisions related to Georgia College students, consult with your department chair or program coordinator/director/assistant director to learn about standard practices. Consult with the Center for Teaching & Learning Instructional Designers, too.

Common statements used on syllabi are online in at Common Syllabus Statements.

... mentorship to improve my teaching?

The Center for Teaching & Learning (CTL) offers confidential midterm course feedback for faculty. CTL offers Peer-Feedback on Teaching (PFoT) where colleagues work with you to identify something you want to improve and then come and observe class sessions and follow up. CTL also offers Small Group Instructional Diagnosis (SGID) where trained facilitators guide students through a 30-minute, group consensus-building process. The facilitator meets the faculty within a week of the data collection to review the student feedback.

... the administration, academic, and non-academic organizational charts with reporting information for Georgia College?

The administration, academic, and non-academic organizational charts are online from the Office of Institutional Research and Effectiveness website.

... forms to use?

All official University forms are online in the Intranet. You can access them from MyGCSU.

Select:

Forms

Examples of forms categories include finance and administration, university payment forms, benefits, employment, employee relations, and payroll.

... resources for working with a librarian for research or teaching?

The library has resources for faculty to support researchand teaching, including research guides, copyright assistance, author resources, and information literacy instruction.

... open education resources?

Learn how to access and use open education resources from Affordable Learning Georgia.

... GC Journeys? / LEAP Georgia College

GC Journeys is a transformative, creative, and uniqueapproach designed to promote preeminence and graduate students who are consummate thinkers and active citizens.

Essential skills (ESs) – Every course at GC teaches one of the AAC&U **Essential Learning Outcomes** (ELO) and each student is assessed using the VALUE rubrics, which correspond to the ELO taught in the course.

- 1. Transformative experiences (TEs) Each native GC student will participate in at least 5 TEs (high-impact practices) prior to graduation. Three of the experiences are built in (First Year Experience, GC Career Planning Milestones, and Capstone). Students have a menu of choices for the other two (including Study Abroad/Study Away, Community-based Engaged Learning, Intensive Leadership Experiences, Mentored Undergraduate Research, and Internships and Field- Based Apprenticeships.)
- Learning nudges Small, targeted interventions designed to improve learning are woven throughout the curriculum and co-curriculum.

The GC Journey's Program authentically assesses each aspect of student learning with a portfolio approach.

As a member of the Association of American Colleges and Universities, Georgia College is a LEAP institution as well as a member of LEAP Georgia.

... Information about carrying concealed guns on campus?

Georgia House Bill 280 allows anyone who is properly licensed in the State of Georgia to carry a handgun in a concealed manner on property owned or leased by publiccolleges with a few exceptions. Additional information is available on the Student Code of Conduct website.



Do I need to. .

... take attendance in my class?

According to the undergraduate catalog and the graduate catalog class attendance policies, you shouldhave an attendance policy stated on the course syllabusthat is distributed to all students.

You are required to report which students are attending ornot attending your course during the first week of classes (or equivalent time for summer terms). This is a federal requirement, and is a critical process to ensure that all students are properly enrolled and that you receive creditfor the students you are teaching.

According to both catalogs, the "instructor has the right toassign a grade of F for excessive absences when a studentexceeds the number of allowable absences specified" on the syllabus attendance policy. To do so, the faculty member must file an "F for Excessive Absences" form withthe Registrar. Students may not drop the course if this grade has been assigned. In addition, you must report thelast date of attendance or participation for any student to whom you assign a grade of F or U.

Per the **Student Absence Policy, General and Religious**, "Faculty members and college officials who are sponsoringofficial activities of the college (i.e., student government, athletics, debate, chorus, band, field trips, etc.) should send a list of the students involved in their activity to the Office of the Provost on the Student Request for Excused Absence form in time for her to approve, and in time for the college sponsor to notify affected faculty by memo before the scheduled absences occur. If that is not done, then the student can be penalized by the instructor for those absences."

Per the Class Attendance Policy, "If a student is representing the University in an official capacity, as verified on a list released from the Office of the Provost, the instructor will not penalize the student for those absences. However, students should consult their instructorbefore anticipated absences."

... submit deficiency reports for my students?

Instructors teaching any core classes (1000 – 2000), must submit midterm grades in PAWS. The submission date is posted on the academic calendar, each semester.

Faculty are strongly encouraged to provide midterm course feedback for all their courses. The University System of Georgia (USG) policy requires students to receive feedback in every course by midterm.

... make reference in my syllabus to policies about accommodations for students with disabilities?

The syllabus must include the **common syllabus statement** for Assistance for Student Needs Related toDisability, which is located on the Registrar website.

Access the Registrar's website, scroll down. **Find:**

... include other information or policies on my syllabus?

According to the Georgia College Policies, Procedures and Practice Manual, "all faculty must prepare a writtensyllabus for each course they teach each semester." Thesyllabus minimum requirements are detailed in the Policies, Procedures and Practice Manual. This syllabusrequirement also applies to independent study courses.

Syllabus formatting may vary according to the program, therefore, refer to the department or program leadership for guidelines.

... report incidents of students experiencing sexual harassment?

According to the **Georgia College Sexual Misconduct Policy** (July 1, 2016), "Georgia College will not tolerate sexual misconduct, which is prohibited, and which includes, but is not limited to, domestic violence, dating violence, sexual assault, sexual exploitation, sexual harassment, and stalking. Georgia College strongly encourages members of the campus community to report instances of sexual misconduct promptly."

As a faculty member, you are considered a "Responsible Employee," which means that you have the authority to "redress sexual violence or have been given the duty of reporting" (Haven for Faculty & Staff, 2016).



... have a key to get into my classroom or the building it's in?

You will need a key to access your classrooms. Each faculty member is assigned a key to classrooms by the manager of the classroom building. If the class is taught in a building other than your discipline, someone in the Dean's office can open the classroom.

... let anyone know if I must miss a class due to illness?

Information about taking sick leave is in the Georgia College Human Resources Policy Manual. According to the Georgia Board of Regents Policy 4.10.1 on Interpretation of Sick Leave, "faculty are responsible for informing their immediate supervisors of any illness that prohibits them from meeting their assigned responsibilities."

...order books for my class?

The Georgia College bookstore is managed by Barnes & Noble. The bookstore will assist you in finding the materials you require for your course. To order books, goto MyGCSU and look for the B&N Bookstore.

... obtain textbook copies for my class?

There isn't a specific, institution wide process for obtaining textbook copies for a class. Check with an administrative assistant inyour department, college, or school about how this is accomplished in your area.

Unless students require a hard copy of a document, consider placing the information in your GeorgiaVIEW/D2Lcourse, the Intranet-based learning management system for Georgia College. All classes, whether face-to-face or online, have an online course environment available for each course. Placing content online negates the need for hard copies.

... place course items on reserve at the library?

The Ina Dillard Russell Library at Georgia College has anumber of resources available for faculty including a service of placing course materials on reserve.

... find out what my classrooms are and where they are located?

The course schedules and classroom locations are handled through the individual department chairs and/or administrative assistants.

... request a new classroom?

Classroom assignments are handled through the individual departments. Contact your administrative assistant for assistance.

... submit grades to the Registrar?

To submit final grades:

- log into MyGCSU to access PAWS
- select Faculty Services > Final Grades (you must be the primary instructor)
- select Term > CRN

The Registrar's office will provide you with a more detailedlist of instructions each semester.

To verify that grades were submitted, access PAWS > Faculty Grade Submission Review.

... change a grade after the grade submission date?

The process for changing a grade is online in the Chair Handbook. The Change of Grade form can be downloaded from the Registrar's website.

... learn more about GeorgiaVIEW, GC's course learning management system?

GeorgiaVIEW provides a collection of tools for course materials and collaboration. The underlying software for GeorgiaVIEW is Brightspace by D2L.

GeorgiaVIEW integrates with several 3rd party applications. Compatibility with tools such as Turnitin, Kaltura, and MS Teams, as well as a variety of textbook publishers provides flexibility and additional capabilities to

Faculty at Georgia College use the Digital Measures database to input data for the annual evaluation. Digital Measures is integrated with your administrative data in Banner and course information in PAWS. You can accessDigital Measures from the Faculty Links menu located in MyGCSU. Learn how to use Digital Measures using the Faculty / Staff Guide.

Digital Measures has four sections – general information, teaching, scholarship/research, and service. Once you have entered your data, you can create a vita and an individual faculty report (IFR).

The procedure for the annual evaluation is available in the Faculty Review System, Philosophy and General Procedures section of the Academic Affairs Handbook.

The Student Disability Resource Center handles requests from students for reasonable accommodations for appropriately documented disabilities and will provide you with information about and assistance in providing accommodations as the need arises.

... grading standards?

Contact the chair of your department or a member of the office of the dean of your college or school. Grading scalesvary from school to school, and grading standards can varyfrom course to course and department to department. The University has a **chart** for equating letter grades and numerical grades.

... Georgia College's Honor Code and Student Code of Conduct?

The Student Affairs office provides general information about the Honor System for all Georgia College students. The Judicial Board enforces the Honor Code and provides information to the Georgia College community about the Honor System. Definitions, violations, and penalties can be found on the Student Affairs web page.

... Academic Dishonesty Policies?

Georgia College acknowledges the need to preserve an orderly process with regard to teaching, research, and public service, as well as the need to preserve and monitor students' academic rights and responsibilities. Since the primary goal of education is to increase one's own knowledge, academic dishonesty will not be tolerated at Georgia College. However, students should consult their instructor before anticipated absences." Faculty with student athletes should review the policy details.

... privacy issues regarding student academic records (FERPA)?

The Family Educational Rights and Privacy Act (FERPA), also known as the Buckley Amendment, protects the privacy of students' academic records. In short, any educational records, including grades, are to be given toindividual students only, and they alone can approve the sharing of their academic information with third parties.

The Office of the University Registrar has a website devoted to FERPA and how it applies to student privacy atGeorgia College. All faculty are encouraged to view the Office of the Registrar's FERPA page.

If a student would like to release academic records to a third party (e.g. parent or spouse), a **FERPA Request Form** must be completed and returned to the Office of theRegistrar.

... Campus Safety

... Georgia College's policy on Consensual Relations?

The policy, designed to help members of the Georgia College community "be aware of their professional responsibilities and to avoid apparent or actual conflict ofinterest, favoritism, or bias," is located under **Amorous Relationships** in the Policy Manual.

"When one party has a professional relationship towards the other, or stands in a position of authority over the other, even an apparently consensual amorous relationshipmay lead to sexual harassment or other breaches of professional obligations. Georgia College prohibits all employees from having a romantic or sexual relationship with any student or employee whom the individual supervises, teaches, or evaluates in any way."

... information about the high school students enrolled in courses I teach?

Georgia College has two programs that allow high school students to take college courses – the Dual Enrollment program and Early College. Highschool students may be enrolled in core classes (1000 – 2000).

- Students in the Dual Enrollmentprogram must complete 10th grade and be on track to complete College Preparatory requirements. Additional information is available online at the Dual Enrollment website.
- Students in the Early College program are in 7th through 12th grade and take courses on campus. The Early College program allows students to complete high school. Many students enrolled in the program are from low-income homes and/or are firstgeneration college bound completers. Additional information is available at the Early College website.
