Pre-Service Certification is required before starting the cohort. The application will require verification of Lawful Presence (form, affidavit, and copy of a photo identification document). A program applicant becomes a Teacher Candidate when:

1. GC Admits the applicant to an initial teacher program conditional upon obtaining PSC certification,
2. Applicant received email from PSC and confirms program, and
3. PSC issues requested certification. Certification should be applied for immediately after acceptance and should be issued before starting an initial teaching program such as a Bachelor of Science.
