- Engaging school partners in supporting juniors and seniors completing internship hours.

- Emphasis on strong communication so teachers and candidates feel confident and supported in their roles.

Willingness to assist with placements and provide information about teacher quality as needed.

● Request for Feedback

- They are asking for ongoing feedback on their processes and improvements.
- Specifically seeking feedback about the **GACE process and new assessment** from teachers, candidates, and anyone who has taken it.
- Early data is limited since few school districts have participated so far.

● Feedback on the New Assessment

- Some teachers mentioned the format feels “easy” (though that may not be the best word).
- The assessment includes various public strategies for different situations.
- The new format may have future implications, even beyond coursework, especially if additional assessments are introduced.

● Transition to a New Data System

- They transitioned from LiveTec to a new Watermark product called Student Learning & Licensure.
- Previously, they used three separate platforms for placement and assessment tracking.

- Now, everything is consolidated into one platform for better management.

Accreditation Preparation (2027–2028)

Upcoming CAPE and Georgia Professional Standards accreditation visits in 2027, with evaluations extending into 2028.

- External stakeholders will be needed for interviews and evidence collection.
- Preparation includes documenting impact, effectiveness, and partnership quality.

• Tracking Candidate Effectiveness

- The department wants to track candidates throughout the program and after they are hired.
- Goal: Connect preparation experiences to real-world effectiveness observed in schools and districts.
- This aligns with accreditation standards.

• Key Accreditation Standards Mentioned

- Standard 1: related to program effectiveness and impact.
- Standard 2: Clinical partnerships.
- Standard 3: Quality assurance and continuous improvement.
