Extended University Update

Extended University is comprised of eight areas: (1) Continuing Education, (2) the Old Governor's Mansion, (3) Public Services and Facility Reservations, (4) the YES Program, (5) High Achievers, (6) Academic Outreach, (7) Production Services, and (8) Communities in Schools - primarily focused on serving the campus and community. This past year, Extended University served 45,459 individuals throughout our community, state, and nation and generated \$1,391,747 in sales and services revenue. In addition, Extended University generated \$1,701,433 in grant funding.

Highlights include:

- Continuing Education held 627 non-credit courses, serving 10,581 students.
- Academic Outreach served 7,522 children and adults in eight counties, provided 3,514 hours of community service, and had 81 Georgia College students lead or instruct programs during the year.
- The Old Governor's Mansion received more than 10,000 tourists.
- The YES Program provided safe afterschool programs for 963 school aged children in grades three through twelve at all six Baldwin County public schools.
- High Achievers enrolled 60 middle and high school aged students in their year-long program. In addition, High Achievers partnered with the YES Program to offer a free summer camp – enrolling more than 290 students.
- Communities in Schools served 3,374 Baldwin County school children and utilized 440 volunteers to provide 8,115 hours of service to the local schools.
- Public Services and Facility Reservations processed 10,302 facility reservations.

Non-Student Minors on Campus

Georgia College offers a variety of athletic camps, science camps, clinics, after-school programs, enrichment classes, continuing education courses, federal and state grants, group tutoring, test preparation courses, and activities which bring non-student minors onto campus. In August 2016, the Board of Regents passed a USG policy to help ensure these minors are protected while participating in campus activities. Georgia College has worked to craft and create written procedures that every department working with non-student minors will be expected to follow.

By May 1, every department on campus working with non-student minors will be required to follow the Georgia College procedures found at: <https://intranet.gcsu.edu/protection-minors>. The procedures include registering your program, running background checks through Human Resources on all employees and volunteers, providing proper training for all staff, using approved forms, and ensuring that proper planning has been completed. Russell Library Faculty Fellows Project

The Russell Library Faculty Fellows Project serves as a pilot study created to support collaborative projects between faculty and librarians/archivists that intentionally integrate library resources into academic courses. This will provide students with numerous opportunities to engage with scholarship and research-based, hands on learning. The Fellow will collaborate with a librarian/archivist to scaffold research assignments in order for students to understand scholarship as a conversation and utilize the librarian/archivist to purchase related materials and/or provide primary source materials for the course. This could also include having a librarian/archivist meet with students during various sessions throughout the semester or incorporate into their D2L courses.
