## Cultural Center Update

The Georgia College Cultural Center aims to provide support for our under-represented student populations by offering services, programs and enrichment opportunities that encourage student success. The Cultural Center is a place where students can meet other students of various backgrounds and embrace the diversity that we strive to increase here at Georgia College.

Beginning on September 1<sup>st</sup>, Stacey Milner became the Director of the Cultural Center. Milner has worked at the university for ten years and was previously an Assistant Director in the Office of Fraternity and Sorority Life, where she has played a key role in revamping the fraternal system. She brings to the position a passion for educating students on the value of diversity and inclusivity in everyday life. Her responsibilities include providing support to under-represented students and creating opportunities for intercultural engagement. The Cultural Center is a department in the Division of Student Affairs and is located in the HUB (Blackbridge Hall).

## Congratulations!

**Andrei Barkovskii, Ph.D., Professor of Biological and Environmental Sciences**, IMERYS, \$32,607. This grant supports the removal of biological contaminants from aqueous media. Control of biological contaminants in aqueous media is needed for medical, public health, food, and other industries. The Barkovskii Lab recently developed a method for removal of bacteria from the above media using particular kaolin products.

**Sequena Moon, Program Manager, High Achievers Program**, CAC Food Program for High Achievers – U.S. Department of Agriculture, \$12,500. The Child and Adult Care Food Program (CACFP) provides aid to child and adult care institutions and family or group day care homes for the provision of nutritious foods that contribute to the wellness, healthy growth, and development of all participants. This grant allows for a daily dinner meal reimbursement for each attendee in the High Achievers Program. Participation in the CACFP program assists with the cost of food so that DHS grant funding can support curriculum programming costs.

## GC Applicant Tracking System Changes

As part of the *OneUSG* initiative, Georgia College & State University will make a change from our current GCSUJobs/PeopleAdmin applicant tracking system to further align our university with the *OneUSG* system. This transition will take place in the upcoming 2018 calendar year (the new system could be available by February 16, 2018). All searches take time to complete and as a result there will be significant overlap of the two systems to meet individual search needs. If a search started in the old system prior to February 16<sup>th</sup>, departments will be able to complete the search in that system. Searches starting after February 16, 2018 will be conducted in the new *OneUSG* system. This change will affect the faculty and graduate assistant searches that take place within the Academic Affairs Division. ## Georgia House Bill 801

Georgia House Bill 801 was recently implemented to incentivize students to pursue STEM (Science, Technology, Engineering, and Math) coursework and ultimately STEM careers by providing a 0.5 point HOPE and Zell Miller GPA boost for select STEM courses. Beginning with the Fall 2017 semester, certain introductory courses in STEM fields have been approved to receive an additional 0.5 point per credit hour in the HOPE and Zell Miller eligibility calculation for students who earn a B, C, or D grade in these courses. HOPE and Zell Miller STEM courses are identified on the semester course schedule.
